Approval of Prior Meeting Minutes

There was one correction to the prior meeting minutes of September 16, 2021: Mrs. Cheek is Vice President and Mr. Jones is Secretary. It was moved by Dr. Morgan and seconded by Mr. Shriver to approve the September 16, 2021 Regular Meeting Minutes with the stated correction.. The vote was unanimous in favor of the motion (AYE- Morgan, Cheek, Shriver). Motion passed-Minutes approved with correction.

Public Comment

No public comment was received.

<u>Correspondence</u>

- SVSU Open House Saturday, September 18, 2021 high school students will be going
 to tour the campus, apply for admission, and attend the tailgate festivities and football
 game versus Wayne State University. SVSU will facilitate the event and cover the cost
 of transportation of students and their parents or accompanying adults. So far there are
 6 students.
- Board Resignation Dr. Morgan stated a letter had been received from Mr. Sylvester
 Jones resigning as a member of the Board of Directors. It was moved by Dr. Morgan
 and seconded by Mrs. Cheek to accept Mr. Jones' resignation letter. The vote was
 unanimous in favor of the motion. (AYE- Morgan, Cheek, Shriver). Motion passed.

Reports

- Principal Report
 - Attendance some of our days are below 75% due to the school having to quarantine the majority of 3 classes due to Covid. As a result, we have been learning virtually for the past 6 school days and will return to in-person learning on Monday.
 - Discipline referrals and suspensions were discussed broken down by male and female students.
 - Enrollment 292 students
 - Transportation Looking into partnering with GISD for transportation of GCI students instead of MTA because of the savings in cost.
 - Facility Update An issue with the septic pump has been discovered in the new edition and 4-5 plumbers/electricians have been involved to resolve the issue because sewage is being pumped under the building. A section of the floor in the hallway had to be torn up to get to the problem. If the vendors are unsuccessful in getting the issue resolved, we may have to cancel school for additional days because the bathrooms will be off limits and the floor is open.
 - SVSU visit will take place on November 8, 2021 and the partnership meeting will take place on November 9, 2021 at 1:00pm.
 - Compliance/Grant Submission 21h grant has been submitted-no feedback yet, 35a(5) application results-we were awarded \$6,304.35 for additional instructional time, E-STAR sub grant was submitted for \$3,500 to enhance our food presence and the students perception.
 - Open Positions paraprofessional, math, science, and social studies teachers (grades 6-12)
- Legal Report Mr. Meihn was unavailable for the legal report.

- Financial Report Mr. Price went over the financial report for Mr. Romzek who is out of town. It was moved by Mr. Shriver and seconded by Mrs. Cheek to accept the financial report. The vote was unanimous in favor of the motion. (AYE- Morgan, Cheek, Shriver). Motion passed.
- GSA Field Rep Report All Board members received the report from SVSU.

<u>Unfinished Business</u>

Board Retreat - Mr. Meihn was to send a suggestion for dates however was not present. Mr. Shriver stated that he will be a father next month so his availability is unsure. The Retreat is tabled for now.

New Business

- Board Candidates No new applications have been received for potential candidates.
 Applications of the two previous candidates, Mr. Fox and Ms. McKay, were discussed.
 Mrs. Cheek moved to accept the application of Ms. McKay to be forwarded to SVSU for consideration to become a board member, Mr. Shriver second the motion. The vote was unanimous in favor of the motion. (AYE- Morgan, Cheek, Shriver). Motion passed.
- Education Program Review Mr. Price stated that due to the length of time required, he recommended that this item be tabled for tonight. He and Mrs. Cheek will discuss this and bring it back to the Board.
- Covid Plan Mr. Price stated the Academy has had 5 staff members and 10 students that have tested positive with Covid since school began on August 9, 2021. The response to the school early on was a lot swifter from the Health Department than now since all schools are in session and as other cases arise in the County. This has caused heightened anxiety among the students and parents. We are expected to follow the Toolkit that has changed three times from the County which outlines communications to parents and quarantines. Mrs. Cheek stated that this can be frustrating because communication is the key.
